Now this Memorandum of Understanding witnesses that:

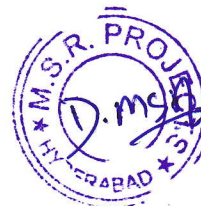

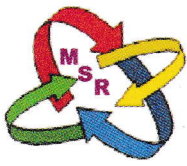
The above said program Live Project shall be conducted at your premises on regular basis.

1.0 ADMISSION PROCEDURES

1.1 Academic Programs – Courses of Study

The classes for the above said courses shall be conducted by MSR Projects. The project completion certificate shall be provided by the MSR Projects.

1.2 Tuition Fees

The fee structure prescribed for the programmers are as follows:-

The tuition fee as fixed by the college as specified above and it will collected by the college management. The amount will be paid by the College to MSR Projects in three installments i.e. first installment of 30% should be at the one week of the program, the second installment of 50% should be provided at the third week of the program (after the completion of project execution) and balance 20% after the completion of VIVA.

2.0 RESPONSIBILITIES OF COMPANY

- 2.1 MSR Projects shall appoint qualified and experienced persons as faculty members.
- 2.2 MSR Projects shall get the consent from the college before admitting the students.
- 2.3 MSR Projects shall arrange necessary equipments for practical training to the students.
- 2.4 MSR Projects shall not collect any amount under any head(s) other than the prescribed fee(s) from the students joining the courses. All amounts collected from the students shall be collected by the college.

3.0 RESPONSIBILITIES OF THE COLLEGE

- 3.1 The college shall be responsible for all administrative work relating to admission, collection of fee, conduct of projects execution.
- 3.2 The college shall provide entire infrastructure facilities including classrooms, laboratories and equipments and qualified staff.
- 3.3 The college shall monitor the quality of the programs through persons appointed by it for the purpose.
- 3.4 This MOU shall be valid for a period of this academic year from this date and can be renewed for a further period on mutual consent.

4.0 JOINT RESPONSIBILITIES

- 4.1 The monitoring of students should be done both by the college and MSR Projects
- 4.2 The schedule of the projects execution shall be decided by both the college and MSR Projects at the commencement of every academic year in mutual consultation.
- 4.3 Any change in the modification relating to the academic programs shall be decided jointly by the college and MSR Projects.
- 4.4 Any issues or implications will be resolved by mutual consultation only.

5.0 MISCELLANEOUS

- 5.1 All payments to be collected by the college under the MOU, shall be made in Indian currency.
- 5.2 MSR Projects shall take care of the fulfillment and compliance of the procedural statutory regulations and formalities in connection with the program execution.
- 5.3 All the terms and conditions of this MOU are subject to the approval of the college management and MSR Projects.
